## ORDINANCE OF THE MINISTER OF FINANCE<sup>1)</sup>

of 18 March 2016

### **on insurance statistics data collected by the Polish Insurance Association**

Pursuant to Article 426(5) of the Act of 11 September 2015 on insurance and reinsurance activity (Journal of Laws item 1844), it is ordered as follows:

§ 1. The Ordinance lays down the scope of insurance statistics data collected in IT databases by the Polish Insurance Association.

§ 2. IT databases shall include data on:

- 1) the insurance referred to in Branch I of the Annex to the Act of 11 September 2015 on insurance and reinsurance activity, hereinafter referred to as the "Act";
- 2) the insurance referred to in Branch II of the Annex to the Act.

§ 3. The data referred to in § 2 shall not include personal data.

§ 4. The data referred to in § 2(1) shall include:

- 1) the amount of a gross written premium by individual and group insurance contracts, hereinafter referred to as "contracts";
- 2) the amount of a gross written premium in respect of periodically paid and single-paid contracts, and the amount of a gross written premium to be paid by a policyholder within 12 months of the date of the contract, by:
  - a) contracts concluded through: insurance agents, tied insurance agents, insurance brokers, salaried employees of insurance undertakings, the Internet, hotlines of insurance undertakings, banks and other entities,
  - b) the insurance classes referred to in Branch I of the Annex to the Act;

- 3) the number of contracts and insured persons by:
  - a) insurance classified in individual insurance,
  - b) insurance classified in group insurance,
  - c) insurance contracts concluded through: insurance agents, tied insurance agents, insurance brokers, salaried employees of insurance undertakings, the Internet, hotlines of insurance undertakings, banks and other entities,
  - d) territorial division units of the country,
  - e) the insurance classes referred to in Branch I of the Annex to the Act;
- 4) information on claims experience with respect to:
  - a) the value of technical provisions gross and net of reinsurance of insurance undertakings by the insurance classes referred to in Branch I of the Annex to the Act,
  - b) the value and number of settled claims by insurance classified in individual insurance and group insurance.

§ 5. The data referred to in § 2(2) shall include:

- 1) the amount of the gross written premium by individual and group insurance contracts;
- 2) the amount of the gross written premium by:
  - a) contracts concluded through: insurance agents, tied insurance agents, insurance brokers, salaried employees of insurance undertakings, the Internet, hotlines of insurance undertakings, banks and other entities,
  - b) the insurance classes referred to in Branch II of the Annex to the Act;
- 3) the number of contracts and insured persons by:
  - a) insurance classified in individual insurance,
  - b) insurance classified in group insurance,
  - c) insurance contracts concluded through: insurance agents, tied insurance agents, insurance brokers, salaried employees of insurance undertakings, the Internet, hotlines of insurance undertakings, banks and other entities,
  - d) territorial division units of the country,
  - e) the insurance classes referred to in Branch II of the Annex to the Act;
- 4) information on claims experience with respect to:
  - a) the value of technical provisions gross and net of reinsurance of insurance undertakings by the insurance classes referred to in Branch I of the Annex to the Act,
  - b) the value and number of settled claims.

§ 6. The Ordinance shall enter into force on the day following the day of its publication.<sup>2)</sup>
